Annual Meeting

Approval of the Budget

The motion to approve the budget made by Carol Pledger and seconded by Charlie Wittingham. The budget was approved with a unanimous vote.

Emily's presentation

- We started the year with appointment-only browsing and equipment use, phased in regular library access and in-person programming
- We saw 40,074 visits (down from 100,000 pre-pandemic). The drop was largely because we haven't been hosting big in-person programs.
- 347 new library cardholders
- 5,000 items added to collection and added some special circulating collections
- Added Recite Me accessibility software for regular site and history site
- 17,833 WiFi sessions.
- New self-checkout station
- Mix of in-person and virtual programs
- Children's programming and tween/teen programming
- Adult programs with speaker programs and language programs, Literacy Connections offered classes and tutoring partners
- Library of Local offered seed libraries and gardening/pollinating programs for kids and adults, early literacy kits, and a chestnut roast—highlighting the library is more than just a space!
- Local history interest is growing. Emily thanked Gary and Brenda for their history room leadership.
- Community Services: Offered giveback opportunities and became a prime pickup location for COVID tests and masks.
- Emily commended Fundraising and Events for all their hard work
- Looking ahead to working with new partners
 - Going to work to provide diverse books at various events
 - Encourage board participation
 - Continue to welcome more people to the library
